Job Title: SENIOR CONSTRUCTION CODE INSPECTOR Department: MULTI

Job Code: 3608 Status: NONEXEMPT Grade: L-8

#### **Summary**

This classification describes a multidiscipline construction code enforcement officer responsible for the enforcement of building codes, zoning ordinances and other applicable ordinances. This position entails a great degree of difficulty in applying the highly technical provisions found in building codes and associated standards, as well as zoning ordinances and other applicable ordinances related to the construction industry and the community at large.

# Duties and Responsibilities

- Conducts field inspections during various stages of construction to ensure code compliance.
- Evaluates and analyzes a wide variety of structural, mechanical, electrical, sprinkler and plumbing installations for code compliance.
- Inspects and monitors the application and the proper use of construction related materials.
- Reviews and analyzes architectural/engineering plans and specifications, shop drawings, research reports, special inspection reports and other technical data for the purpose of determining whether an installation is code compliant or for the issuance of permits.
- Applies engineering principles and practices in the technical examination and analysis
  of wood structures, simple steel and masonry structures.
- Performs electrical load calculations, plumbing calculations and analyses of soil conditions.
- Inspects and monitors the installation, maintenance/repair of elevator equipment per elevator safety codes.
- Conducts and monitors the acceptance test and the periodic testing of elevator equipment.
- Responds to complaints generated from citizens, staff, contractors, design professionals
  or other interested parties as they relate to assigned areas of responsibility.
- Conducts legal investigations to determine whether violations of building codes, zoning ordinances, flood plains, parking stations or other applicable city ordinances exist.
- Prepares cases for review by the city prosecutor and gives testimony in court.
- Prepares clear, concise and consistent reports noting specific code violations and items inspected in order to clearly communicate intent to interested parties.
- Reviews and interprets building codes per modern construction methods and engineering practices.
- Serves as a team captain during joint inspections/investigations.
- Performs related duties as required.

#### **Technical Skills**

Considerable knowledge of:

The materials, methods and practices involved in the construction trade standards, inspection practices, testing devices and corrective measures applicable to building codes and regulations.

#### Ability to:

Develop and maintain a professional image.

Develop and maintain positive working relationships with builders, contractors, design professionals, other staff members and the general public.

Express oneself with clarity and conciseness both orally and in writing.

Deliver quality service in a manner that minimizes conflict.

Work under stressful conditions.

Defuse hostile situations and resolve conflict.

Accept direction and work independently.

Apply independent judgment based on sound reasoning and logical thinking.

Enter and maintain inspection data on a computer system.

Use two-way voice radio equipment.

Use and manipulate any tools or testing equipment associated with conducting an inspection.

# Education and Experience

Accredited Bachelor's degree with major course work in engineering, architecture, fire science construction technology or construction management and one (1) year acceptable codes inspection or construction trade experience.

OR

High school graduation and five (5) years of acceptable codes inspection or construction trade work experience.

OR

An equivalent combination of education and experience.

### Certificates/ Licenses/Special Requirements

- Must pass a background check, pre-employment drug screen and post-offer physical examination as prescribed by the City.
- Must possess a valid State –issued driver's license in accordance with the City of KCMO policies.
- Must possess the following certificates from the International Code Council (ICC):
  - ICC Residential Building Inspector B1
  - ICC Residential Electrical Inspector E1
  - ICC Residential Mechanical Inspector M1
  - ICC Residential Plumbing Inspector P1
  - ICC Commercial Building Inspector B2
  - ICC Commercial Electrical Inspector E2
  - ICC Commercial Mechanical Inspector M2
  - ICC Commercial Plumbing Inspector P2

And one of the following certificates:

- NCPCCI Elevator General 6B
- ICC Accessibility Inspector/Plans Examiner -- 21
- NAESA Qualified/Certified Elevator Inspector (QEI/CEI)
- Inspectors assigned to the Elevator workgroup, in addition to requirements above, must also:

Obtain Qualified/Certified Elevator Inspector (QEI/CEI) certification as awarded by NAESA International within eighteen (18) months following date hired or assigned to the workgroup.

- For individuals in this job classification or with exams passed prior to (effective date), the following certificates administered by the National Certification Program for Construction Code Inspectors (NCPCCI) may be substituted for the corresponding ICC certificate as shown:
  - NCPCCI Building Inspector One- and Two-Family Dwellings 1A or ICC Residential Building Inspector – B1
  - NCPCCI Electrical Inspector One- and Two-Family Dwellings 2A or ICC Residential Electrical Inspector – E1
  - NCPCCI Mechanical Inspector One- and Two-Family Dwellings 4A or ICC Residential Mechanical Inspector – M1
  - NCPCCI Plumbing Inspector One- and Two-Family Dwellings 5A or ICC Residential Plumbing Inspector – P1
  - NCPCCI Building General 1B or ICC Commercial Building Inspector B2
  - NCPCCI Electrical General 2B or ICC Commercial Electrical Inspector E2
  - NCPCCI Fire Protection General 3B or ICC Commercial Building Inspector B2
  - NCPCCI Mechanical General 4B or ICC Commercial Mechanical Inspector M2
  - NCPCCI Plumbing General 5B or ICC Commercial Plumbing Inspector P2

### And one of the following:

- NCPCCI Elevator General

- ICC Accessibility Inspector/Plans Examiner 21
- NAESA Qualified/Certified Elevator Inspector (QEI/CEI)
- Inspectors assigned to the Elevator workgroup, in addition to requirements above, must also:

Obtain Qualified/Certified Elevator Inspector (QEI/CEI) certification as awarded by NAESA International within eighteen (18) months following date hired or assigned to the workgroup.
