



## City of Kansas City, Missouri Job Class Specification

**Job Title:** UTILITY REPAIRER

**Department:** WATER

**Job Code:** 5424

**Status:** NONEXEMPT

**Grade:** L-5

### Summary

This is skilled work under dangerous and adverse working conditions as a crew member in the installation and repair of water and sewer systems.

Work involves strenuous physical tasks while working in excavations or from inside buried conduits frequently under adverse climatic conditions and must be performed within established safety guidelines. Duties are usually performed as a crew member although employees of this class are expected to use judgment and discretion in determining work methods and procedures necessary to carry out assignments. Work includes laying water and sewer conduits, shoring of deep excavations and hand excavations in deep trenches. Work assignments are received through oral and written instructions and are inspected in process and upon completion. Duties on occasion will require individual to serve as the crew truck driver.

### Duties and Responsibilities

- Participates as crew member or lead worker in the installation, maintenance or repair of water and/or sewer systems and appurtenances.
- Operates regulating valves, keys and other controls; repairs broken water and sewer systems as required.
- Lays new lines to grade by hand or by guiding back hoe, hoist or crane operations; builds and repairs manholes; and installs valves and other regulating controls.
- Operates jackhammer in cutting and breaking concrete, asphalt or rock; removes waste material from work site.
- Operates tapping equipment to make taps in water or sewer lines.
- Assists in digging trenches and other excavations; shores excavations.
- Performs backfilling and street restoration duties.
- Operates various types of motorized construction and maintenance equipment.
- Performs related duties as required.
- Assists in the set-up of work zones and jobsite restoration.
- Participates in the Cities snow removal operations.

**Technical Skills**

- Must possess knowledge of the types and uses of common hand tools, materials and standard equipment used in water and sewer construction and maintenance work; the underground utility markings; the operation, routine maintenance and safety requirements of moderately heavy trucks and construction equipment.
- Must possess ability to perform laboring tasks involving physical strength and endurance under variable weather conditions; maintain simple records and provide routine oral and written reports as to work activities; operate automotive, construction and maintenance equipment skillfully, safely, and according to traffic laws and regulations and to make minor operational adjustments to assigned equipment.
- Must possess ability to work effectively with team members on maintenance crews.
- Must demonstrate knowledge of blueprint reading and map reading on a computer based Geographical Information System (GIS).
- Must possess skill in the use of hand tools and the operation of relatively complex power equipment.
- Must possess ability to perform addition, subtraction, multiplication, and division of whole numbers and fractions.
- Must be able to speak, read or write English.

High school diploma or GED and one year of utility maintenance and repair experience.

- Must possess a valid State –issued driver's license in accordance with the City of KCMO policies.
- Possession of a valid CDL (Commercial Driver's License) issued by the State of Missouri prior to the end of the employee's probationary period (Appropriate CDL will be determined by the department).
- Must pass a physical examination as prescribed by the City.
- Must pass a background check as prescribed by the City.
- Will be required to pass a pre-employment drug screen
